## Privacy Policy of ATERIMA Europe Sp. z o.o. sp. k.

#### I. General

Protecting privacy and personal data is extremely important to us. We make every effort to ensure that the processing of personal data is carried out correctly, in accordance with applicable laws and respecting the rights of those who have provided us with their personal data.

Please read this policy before using our sites, or the services we provide. Trust us, we are your partner!

#### II. Personal data processing

When you provide us with your personal data, ATERIMA Europe Sp. z o.o. sp. k., which owns the ATERIMA Group, ATERIMA WORK, ATERIMA MED and ATERIMA HR brands (hereinafter: ATERIMA) becomes their controller.

By filling out a form or simply contacting us, you are providing us with your personal information, and we guarantee that your information will remain confidential.

Thus, if, for example, you have expressed a desire to participate in the recruitment we are conducting, your data shall be used only for this purpose. If, on the other hand, you enter into a contract with us, your data shall be used for the purpose of performing the contract concluded with us.

Personal data is often processed on the basis of consent (e.g., in the case of recruitment). However, there are many more bases for processing, sometimes it may be a contract, sometimes it may be the need to defend or assert a claim, or finally the need to comply with certain legal obligations incumbent on the personal data controller. So consent shall not always be necessary.

We may also process your personal data if the processing is necessary for our legitimate interests or for the interests of third parties, provided that the above does not violate your interests or rights as an individual. Legitimate interests include, for example, managing our relationship with you or your company or organization; improving our services

and solutions or developing relationships with business partners.

When you contact us by phone, form or email, you naturally provide us with your personal information such as your name, contact information and your phone number and email address as the sender of the message, among others. Moreover, you can also include other personal information in the body of the message. In this case, the legal basis for the processing of personal data shall be your consent resulting from the initiation of contact with us. Your personal data provided to us in the course of e-mail contact is processed solely for the purpose of handling your inquiry or registering for our database of job seekers, participating in our training courses, webinars, promotional campaigns and loyalty programs. The contents of the correspondence may be subject to archiving.

Remember that the provision of personal data is always voluntary. Be aware, however, that if you do not provide your data, you shall not be able, for example, to take part in the recruitment conducted by us (having no information about you, we are not able to match you with a suitable offer).

We shall be sharing your personal data with companies affiliated and cooperating

with ATERIMA Europe Sp. z o.o. sp. k. based in Krakow, related and cooperating entities and our trusted partners and contractors in order to present you with job and employment offers.

ATERIMA employees have been duly authorized to process personal data and maintain confidentiality in this regard.

We shall be processing your data such as name, email contact details, phone number, province, among others, and we may also process data such as date of birth, education, professional qualifications, past employment history, image. If you give your consent we will also be able to process sensitive data about your health.

When processing personal data, we strive to ensure that it is properly secured and that unauthorized persons do not have access to it. To this end, we have implemented a number of measures and appointed a Data Protection Officer who shall be in contact with the relevant supervisory authority. We guarantee you the confidentiality of any personal information you provide to us. We ensure that all security and data protection measures required by data protection legislation are taken. Your personal details processed with due care and protected against unauthorized access. The personal data that you directly provide to us shall be processed only in the territory of the European Union (refer to the third-party data collection cookie policy). In the recruitment process, your personal data may be subject to profiling, including automated data processing, and you may exercise your right to object to such processing of your data. We do not transfer data to third countries. However, remember that you should also protect your personal information. Do not share them with others if it is not necessary.

# III. What rights do you have?

Remember that you decide to what extent and for what purpose your personal data is processed. ATERIMA takes into account your decisions regarding your personal data.

In connection with our processing of your personal data, you have the following rights:

- the right to to access, rectify, erase or limit the processing of my personal data,
- the right to object to the processing,
- the right to transfer of data,

- the right to withdraw your consent to the processing of personal data for a specific purpose, if you have previously given such consent,
- the right to lodge a complaint with the Supervisory Authority.

If your data is processed on the basis of consent, you can revoke it at any time. Remember, however, that after its withdrawal it shall not be possible for you to use the services offered by us and that the withdrawal of consent shall not affect the legality of data processing before its withdrawal. The same is true in the case of a request addressed to us to delete your personal data. Please note that we will not always be able to delete your personal data right away (e.g., after we terminate our cooperation with you, we must keep it for a period of time as required by law).

We shall process your personal data until you withdraw your consent, if the basis for processing is the consent you gave us, until the purpose for which we process your personal data has been fulfilled, until the current recruitment process is completed, or if you have given your consent for future recruitment processes for a period of 36 months from the moment we obtain your consent or until the expiration of the period resulting from the statute of limitations for claims or other legal provisions.

You can update and change your personal information at any time. In certain cases (e.g., when your data is processed for direct marketing of services provided by the controller), you have the right to object to the processing of your personal data.

If you believe that your rights regarding personal data have been violated (e.g., the data has found itself in the hands of an unauthorized person) notify us. This will enable us to effectively protect your rights. You are also entitled to file a complaint with the National Supervisory Authority.

#### IV. Cookies policy

Our website, like almost all other websites, uses cookies, to provide you with the best experience of using the site.

Cookies are small text information stored on your terminal device (e.g. computer, tablet, smartphone), which can be read by our data communications system.

Cookies allow us to:

- ensure the proper functioning of the site,
- improve the speed and security of using the site,
- improve the features available to you on the site,
- use analytical tools,
- use marketing tools,
- display YouTube videos on the pages,
- provide community functions.

We use cookies so that you can use the site in a comfortable way. The following third-party cookies may function within our site:

When you visit the site for the first time, you will be shown information about the use of cookies. You can always withdraw your consent by deleting cookies and changing the cookie settings in your browser. Note, however, that disabling cookies may cause difficulties in using the site, as well as many other websites that use cookies.

Cookies are computer data, in particular text files, which are stored in the end device of the Service User and are intended for use on the Service website. Cookies usually contain the name of the website from which they come, the duration of their storage on the terminal and a unique number.

What do we use "cookies" for?

Cookies are used for:

- adjust the content of the Website to the user's preferences and optimize the use of the Website,
- in particular, these files allow for the recognition of the Website User's device and appropriately display a website tailored to its individual needs,
- creation of statistics that help to understand how the Users of the Website use the websites, which allows to improve their structure and content.
